

## **My Lenovo Rewards \$1,000 for \$1,000 in Points Giveaway**

### **OFFICIAL RULES**

**June 2025**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. Entry into the My Lenovo Rewards \$1,000 for \$1,000 in Points Giveaway ("Sweepstakes") constitutes your acceptance of these Official Rules.

**DATES:** This Sweepstakes will be open from June 9, 2025 at 3:00am EST until June 30, 2025 at 3:00am EST (collectively, the "Entry Period.")

**WHO MAY ENTER:** Open to all registered members of the My Lenovo Rewards program who are (a) legal residents of the fifty (50) states of the United States and the District of Columbia and Canada, and (b) 18 years of age or older or have otherwise reached the age of majority on the state/country in which they reside. THIS SWEEPSTAKES IS VOID WHEREVER RESTRICTED BY, WITHOUT LIMITATION, FILING OR REGISTRATION REQUIREMENTS, OR IS OTHERWISE PROHIBITED OR RESTRICTED BY LAW. Individuals employed or contracted by Lenovo (United States) Inc. ("Sponsor"), or its parent and affiliated companies, subsidiaries, and/or advertising and promotion agencies (collectively, "Sweepstakes Parties") at any time during the Entry Period, and members of their immediate family or persons living in the same household, are not eligible. Government employees (including federal, state, and local officials) may only enter and accept a prize if doing so is permitted under applicable laws, regulations, and policies governing the acceptance of gifts and prizes. Entrants must follow all instructions provided by Sponsor to enter.

**ALTERNATIVE METHOD OF ENTRY (AMOE):** To enter into the Sweepstakes without taking the above actions, Entrants must be a My Lenovo Rewards member and must send an email with their full name, complete address, and email address to [mmiller10@lenovo.com](mailto:mmiller10@lenovo.com). All Email entries must be sent during the Entry Period, and received on or before June 30, 2025, to be eligible for the Sweepstakes.

All eligible entries received during the Entry Period will be entered. **Limit one (1) entry per person per week of the Entry Period.** Although subsequent attempts to enter may be received, only the first entry received from a particular individual during each week of the Entry Period will be eligible; subsequent attempts to enter will be disqualified. All entries that do not conform to or satisfy any condition of these Official Rules may be disqualified by the Sponsor.

Entries may not be sexually explicit or suggestive; unnecessarily violent; derogatory of any ethnicity, race, gender, religion, sexual preference, disability or age group; or profane or pornographic. Additionally, entries may not defame, misrepresent or contain disparaging or libelous remarks about Sponsor (or its products or services), or other people and/or companies; contain any offensive or vulgar language; or depict any pornographic or illegal act. Any entries containing such subject matter or any other inappropriate content, as determined by Sponsor in its sole and absolute discretion, will be considered ineligible and will not be part of the Sweepstakes.

By submitting an entry, each Entrant agrees that his or her entry complies with these Official Rules. Each Entrant also agrees that Sponsor may disqualify the Entrant from the Sweepstakes if Sponsor believes, in its sole and absolute discretion that an entry fails to comply with these Official Rules. If Sponsor rejects any entry, such entry will be disqualified and will not be considered a valid entry. The submission of an entry is solely the responsibility of the Entrant. Automated entries (including but not limited to entries submitted using any robot, script, macro, or other automated services) are not permitted and will be disqualified. **HOW TO WIN:** At 3:00am ET on June 30, 2025, the Entry Period will be closed in its entirety. Following each week (Monday through Sunday) during the Entry Period (i.e., on June 16<sup>th</sup>, June 23<sup>rd</sup> and June 30<sup>th</sup>), one (1) winning Entrant from the pool of eligible entries received during the immediately prior week will be randomly selected to win a Prize. Winners will be chosen each Monday following the relevant week (i.e., on June 16<sup>th</sup>, June 23<sup>rd</sup> and June 30<sup>th</sup>). The winners will be notified by Sponsor via email.

**Limit one prize per person.** Note: You are not a winner of any prize until you have been verified as a winner by Sponsor. Decisions of Sponsor are final in all matters relating to this Sweepstakes.

**PRIZES:** There will be a total of three (3) winners during the Sweepstakes who will each receive One Million (1,000,000) My Lenovo Rewards points (ARV \$1,000) to use toward the purchase of Lenovo products via the Lenovo.com website (each, a “Prize”). The total AVR of all Prizes in the Sweepstakes is approximately \$3,000.
